

课程简介：

《美国、中国与全球安全》(课程号：02419640)是北京大学国际关系学院与斯坦福大学亚洲安全研究中心合开的研究生课程。斯坦福方面的课程负责人是前美国驻阿富汗大使、现任斯坦福大学美国亚洲安全研究中心主任 Karl Eikenberry，北大方面的课程负责人是国际关系学院副院长范士明副教授。联合课程主要包括以下主题：中美关系、防止核武器扩散、海上安全、网络安全、恐怖主义、经济投资与贸易、能源与环境治理。2016 年和 2017 年春季学期，斯坦福方面有 10 位相关领域的资深教授参与授课，其中包括美国第 12 任能源部部长、1997 年诺贝尔物理学奖获得者、现任斯坦福大学物理学教授朱棣文 (Steven Chu)。北大方面有 9 位国际关系学院的任课老师参与授课，其中包括国际关系学院院长贾庆国教授。

2016 年春季学期第一次开课就受欢迎，2017 年春季学期更是有超过 60 名学生选择本课程 24 名北大学生（原定 22 名学生）在北京大学斯坦福中心高沉浸式学习教室与大洋彼岸斯坦福大学 21 名学生通过实时视频连线跨越时差进行在线课堂学习。这种“面对面”的沟通方式，让两校的老师和学生有限的时间内最大限度地对国际问题研究发表真知灼见。课堂上师生之间积极互动，学生之间热烈讨论，课后学生们纷纷表示，一个半小时的授课时间过于短暂，意犹未尽。

Brief:

In Spring 2016, SIS PKU and Stanford's U.S.-Asia Security Initiative launched an innovative new graduate-level course - "The United States, China, and Global Security" (02419640) - a class taught simultaneously at SCPKU on Peking University's (PKU) Beijing campus and Stanford University using a high definition video teleconference facility called the Highly Immersive Classroom. The course led by former U.S. Ambassador to Afghanistan Karl Eikenberry and PKU professor Fan Shiming. It featured topics relevant to current U.S.-China relations and their respective roles in regional and global security, including U.S.-China Relations, Nonproliferation, Maritime Security, Cyber Security, Terrorism, Finance, Investment, and Trade, Energy and the Environment and Governance. Lecturers from PKU, Dean of the School of International Studies Jia Qingguo, and arms control and disarmament expert Han Hua; and from Stanford included nuclear scientist Siegfried Hecker, former U.S. Secretary of Energy Steven Chu, and Thomas Fingar, a former deputy director at the U.S. Office of the Director of National Intelligence.

Despite being separated by nearly 6,000 miles, in Spring 2017, 24 students in Beijing and 21 students in Palo Alto held 'face-to-face' conversations via high definition videoconference in a course taught by American and Chinese scholars. The venue, known as a 'Highly Immersive

Classroom,' enabled the distance learning experience between the two universities, using advanced software to create a cross-Pacific virtual classroom. All discussions were off-the-record to encourage candid exchange of ideas.
